MODIFY

THE DEPARTMENT OF FINANCE (8860)

REPORT NO. 1 TO SUSPEND THE REPORT UNTIL THE STATE IS ABLE TO START PAYING LOCAL MANDATES.

THE DEPARTMENT OF FINANCE (8860)

ELIMINATE REPORT NO. 2, BUT REQUIRE THE DEPARTMENT TO POST DATA ON MONTHLY CASELOADS ON THEIR WEBSITE.

CALIFORNIA EMERGENCY MANAGEMENT AGENCY (0690)

ELIMINATE REPORTS NO. 1, 2, AND 3 AND INSTEAD IMPOSE THE FOLLOWING REPORTING REQUIREMENTS ON THE NEWLY-FORMED BOARD OF STATE AND COMMUNITY CORRECTIONS (BSCC) AND CALEMA:

- A. REQUIRE BSCC AND CALEMA, AS APPROPRIATE, TO COLLECT INFORMATION FROM LOCAL ENTITIES FOR AN ANNUAL REPORT TO THE LEGISLATURE ON ALL THE REALIGNMENT GRANT PROGRAMS

- B. REINSTATE THE JOINT LEGISLATIVE BUDGET COMMITTEE REPORTING REQUIREMENT FOR CALEMA THAT WAS ELIMINATED IN THE BUDGET, AS APPROPRIATE, AND PROVIDE THE SAME REQUIREMENT ON BSCC FOR THE VERTICAL PROSECUTION PROGRAMS IN REPORTS 2 AND 3.
